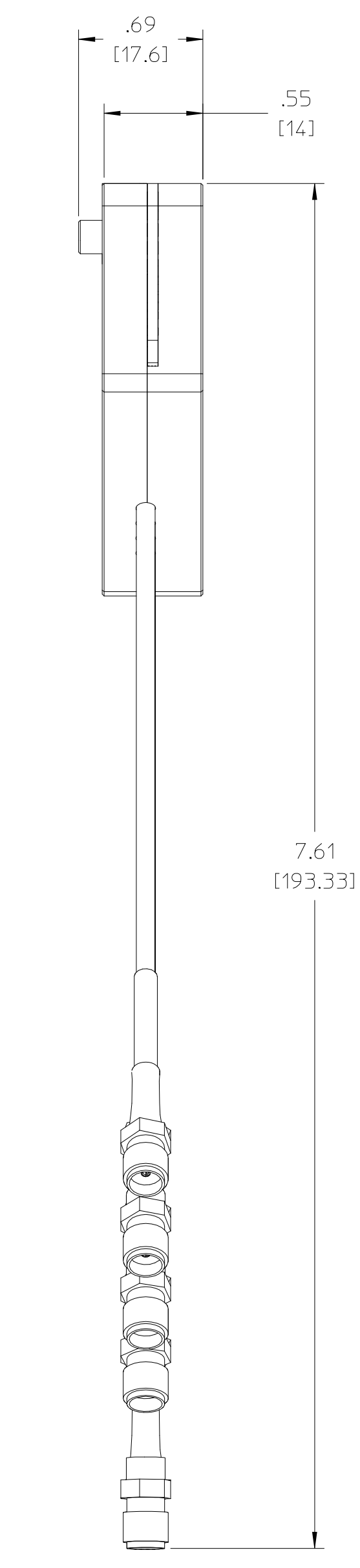
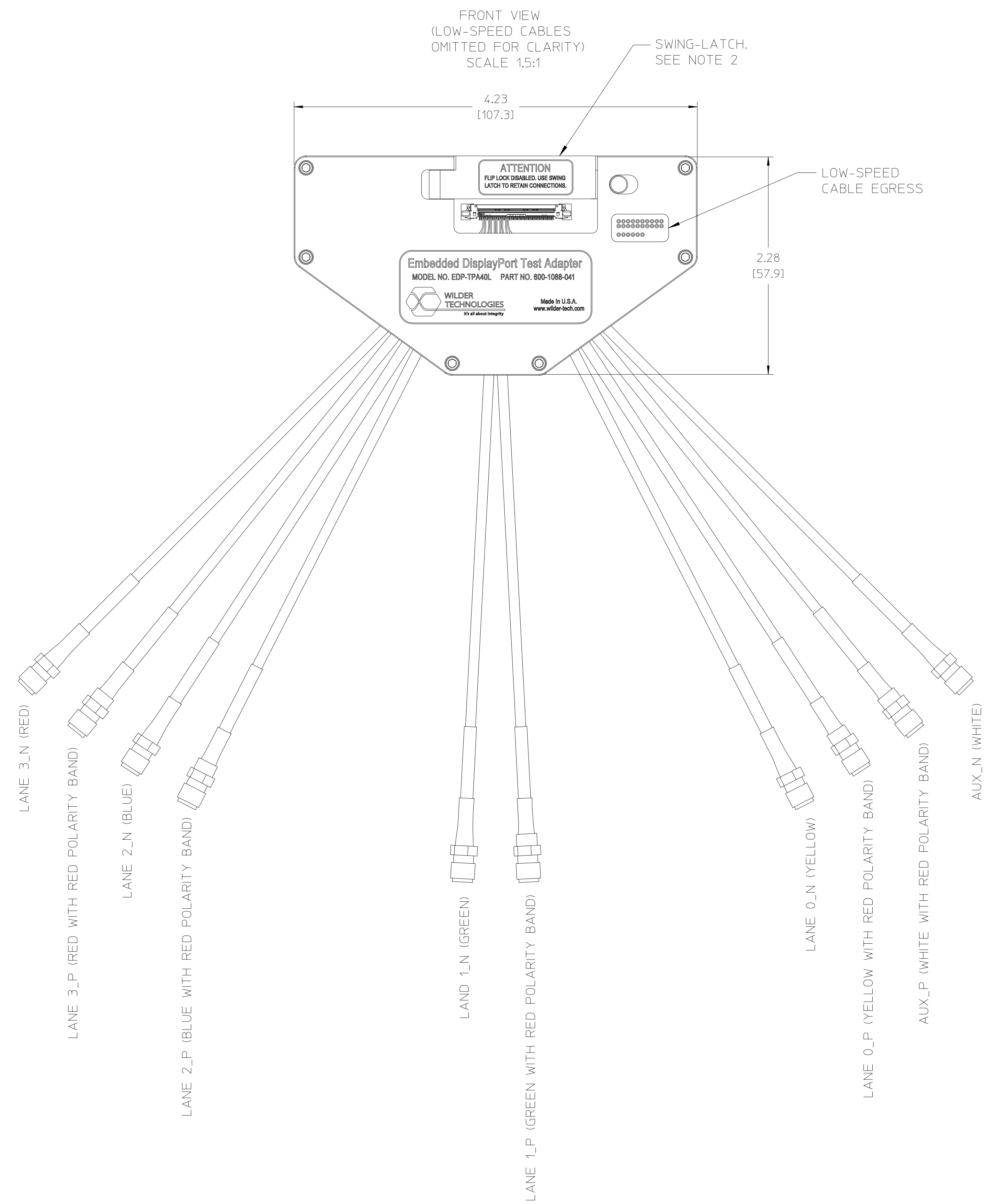

- THE 6-POSITION LOW-SPEED CABLE (NOT SHOWN) IS APPROXIMATELY 13-INCHES LONG FROM POINT OF EXIT ON THE TEST ADAPTER TO MINIMIZE STRESS ON SMA CONNECTIONS TO THE OPTIONAL AUXILIARY CONTROL MODULE, ORDERED SEPARATELY, FOR CERTAIN TESTS.
