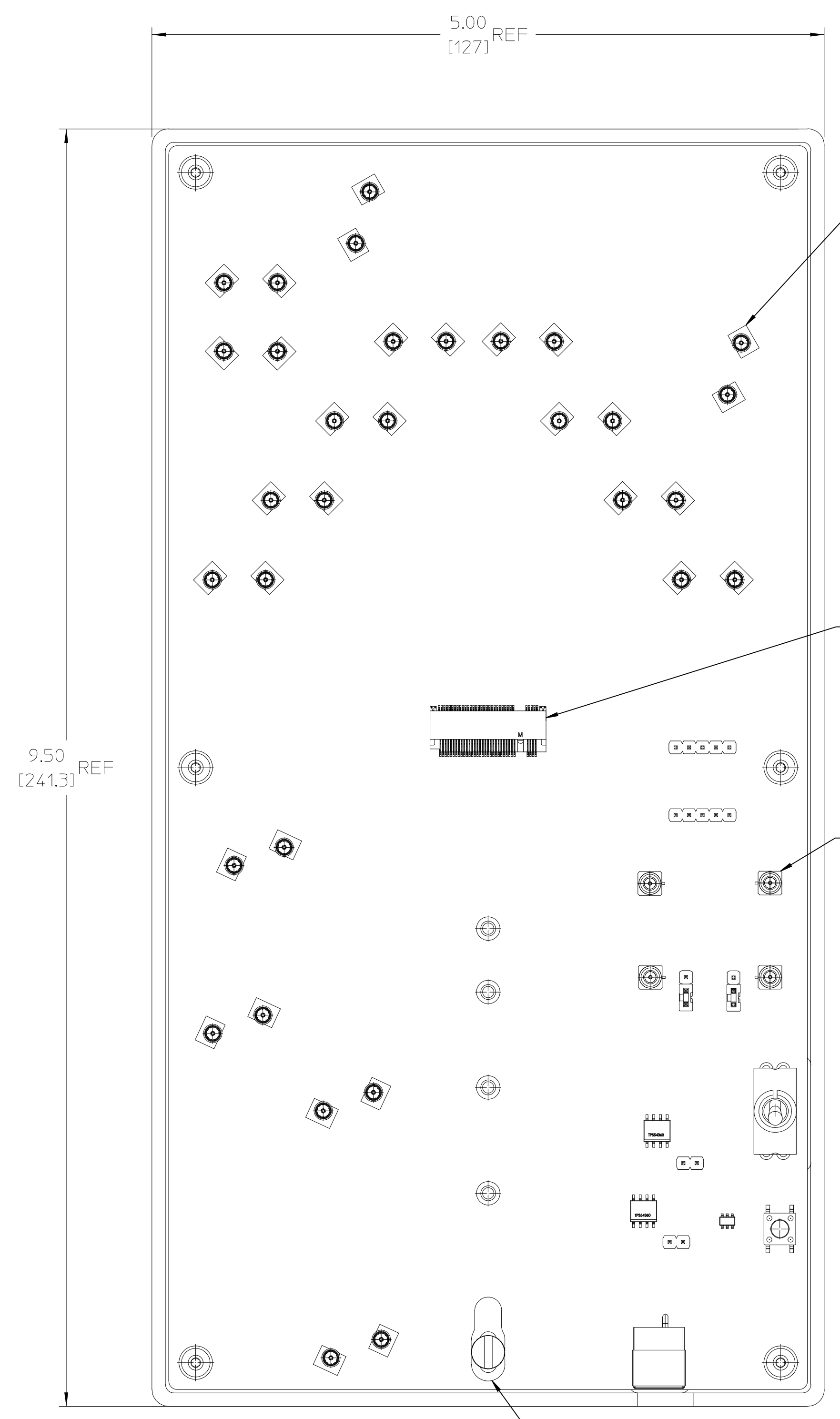

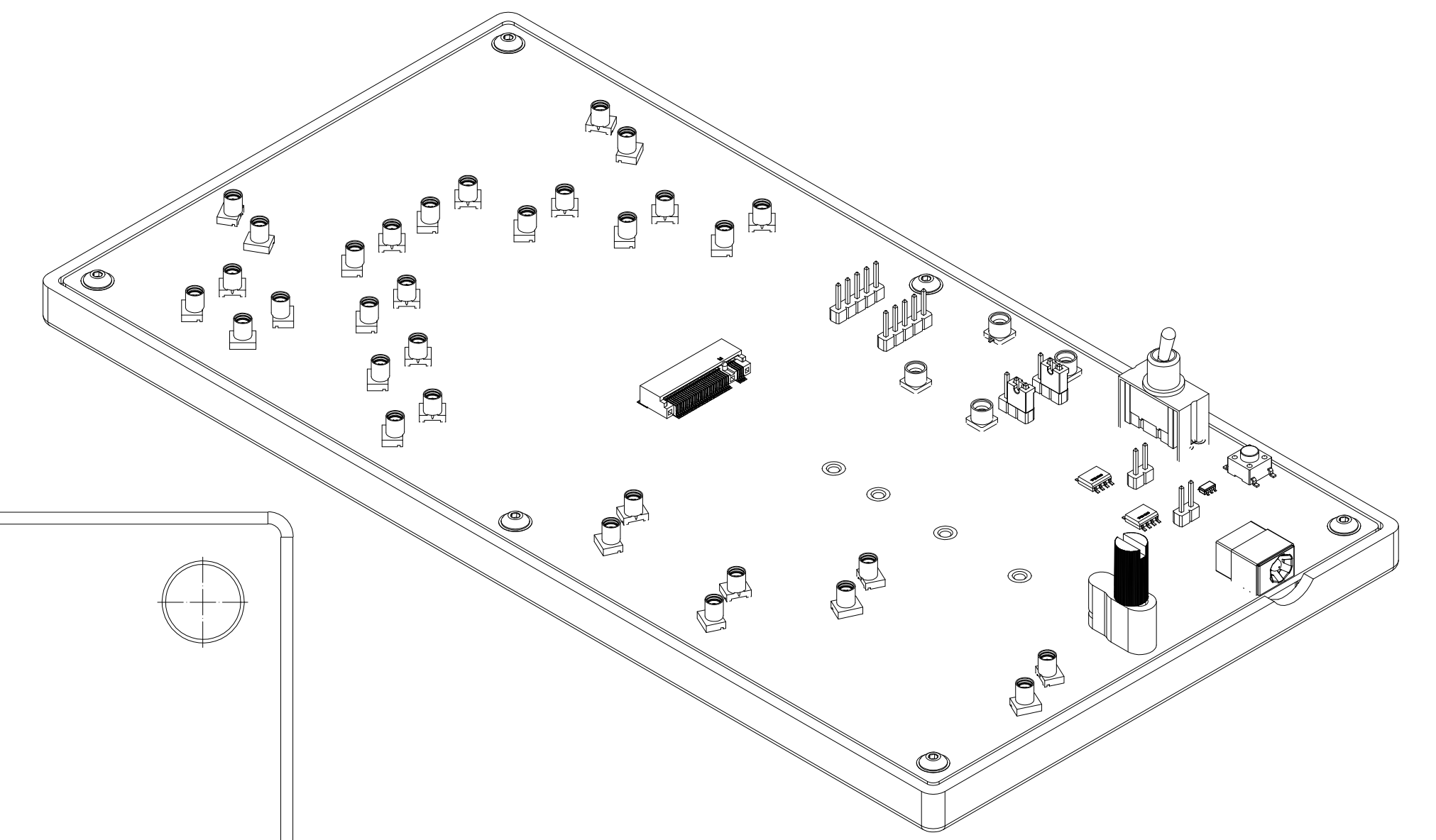
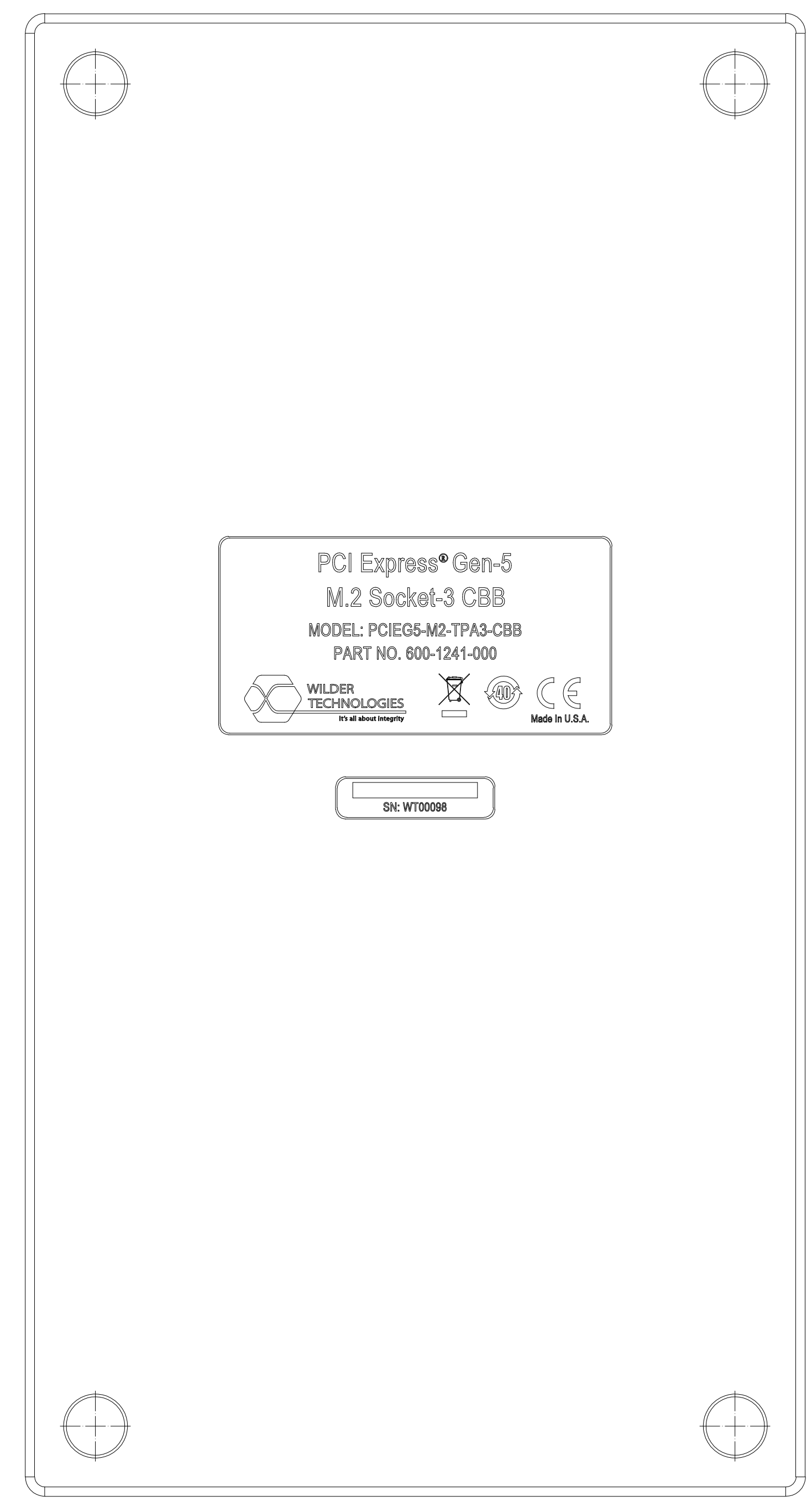


32X VERTICAL MMPX CONNECTORS, REF
